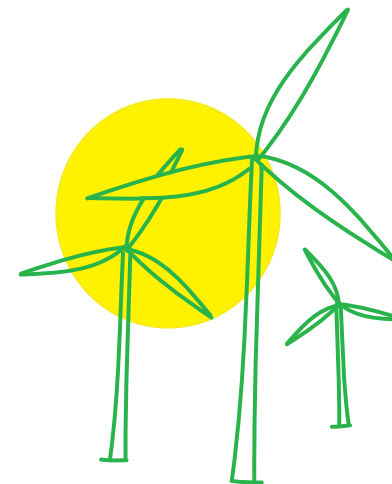

Sierra Club Ontario's
GREEN ENERGY CAMPAIGN

Sierra Club Ontario's Green Energy Campaign promotes sources of energy that we can all breathe easy with.

Ontario's energy future can be based on renewable power and greater conservation. Dangerous, expensive nuclear and polluting fossil fuels must be phased out. Sierra Club was instrumental in Ontario's phase-out of its coal-fired plants. Let us continue to work together for cleaner and greener sources of renewable energies.



WHAT WE HAVE BEEN UP TO

Sierra Club Ontario (SCO) intervened in both applications by the Ontario Power Generation (OPG) to extend the life of two old and troubled nuclear plants - Darlington and Pickering - both of which are dangerously close to Ontario's center of population, the Greater Toronto Area. Having reviewed and commented on the materials filed by OPG with the Canadian Nuclear Safety Commission, SCO argued that there was a failure to conduct a proper environmental and public health assessment.

Moreover given the highly mobile pollutants involved with these nuclear operations, including cancer causing tritium, SCO also called for an assessment that would consider the likely trans-boundary impacts across Lake Ontario at New York. Sierra Club, being a binational organization, filed letters from Sierra Club Atlantic Chapter (New York) with the Commission noting that the 1991 Canada - US Air Quality Agreement and the 2012 Great Lakes Water Quality Agreement requires notice and assessment of projects with likely adverse environmental impacts to be done in advance of approval.

WHAT'S NEXT?

Sierra Club is calling upon the International Joint Commission for the establishment of a Nuclear Task Force as well as a public inventory of proposed licensing applications for new and existing nuclear facilities. This list of licensing applications should be maintained and updated on a public registry, to enable meaningful cumulative impact and risk assessment.

Sierra Club has an active anti-tar sands campaign that includes GTA participation in the Stop Line 9 efforts to prevent permitting of Enbridge Line 9 carrying Diluted Bitumen in old pipes, threatening our rivers and water supply. Ontario Chapter efforts are only just part of our National anti-nuclear work. Sierra Club has recently received funding to intervene in Cameco's application to expand the world's largest uranium mine. Our sights are on engaging the Arctic Council to call for an environmental Impact assessment.
